### MEMBERSHIP COLLECTION NOTICE

Wembley Golf Course (WGC) collects this information for the purpose of providing customers access to, and use of WGC facilities and services through its membership program operating at 200 The Boulevard, WEMBLEY DOWNS WA.

Collected information is also used by WGC to facilitate related operational and administrative activities, enabling financial transactions, statistical analysis, facility based marketing activities, hospitality services, customer communications and the related functions for which this information was primarily collected and required for WGC to manage its business activities.

Unless otherwise stated at the time of collection, only authorised agents of WGC and Town of Cambridge officers can access information exchanged directly with WGC.

There may be instances that require sharing of information by WGC with external sources to provide services. In such cases, the WGC may share this information with other West Australian state agencies and their officer authorised by law, financial institutions or contracted service providers.

Where information is collected for the purpose of golfing lessons or hospitality services, this information may be shared with the resident operators located on the WGC grounds to facilitate services.
